Our legislative effort in 2019 is an ambitious one. From larger concepts, like fixing Oregon's school personal records loophole ... To smaller concepts, like improving land transferring within the highly successful Deschutes Forest Collaborative, or studying news ways that we can conserve valuable water resources. While many of our drafted concepts have been amended into larger legislative efforts, I wanted to take a moment to highlight a few of our legislative priorities in 2019. In future newsletters, I'll highlight individual concepts and talk about their progress in building.





**HB 2892** - Allows student to wear dress uniform issued by Armed Forces of United States during high school graduation ceremony if certain conditions are met.

**HB 2175** - Removes restriction on maximum number of hours that certain employers may require or permit employees to work in single workweek.

**HB 2237** - Creates income tax credit for operation costs of housing for agricultural workers.

**HB 2315** - Modifies provisions regarding division of land by eliminating purchase requirement when land is acquired by provider of public parks or open space, or by not-for-profit land conservation organization.

**HB 2819** - Requires Water Resources Department to establish pilot program to make conserved Columbia River water available to holder of water right in critical ground water area in exchange for holder reducing appropriation of ground water.

**HB 2115** - Directs Department of Human Services to report information regarding prescription of psychotropic medications to children in foster care.

**HB 2222** - Requires State Forestry Department to annually report to Legislative Assembly or interim committee regarding development, implementation and administration of Oregon Forestland-Urban Interface Fire Protection Act.

**HB 2317** - Designates May of each year as ALS Awareness Month.

**HB 2327** - Relating to safe schools to learn.

**HB 2503** - Directs Office of Emergency Management to study and make recommendations regarding funding of search and rescue operations.

**HB 2673** - Directs Department of Education to create Oregon Educational Support Professional of Year Program.

**HB 2916** - Expands transitional housing accommodations allowed inside urban growth boundary to include all recreational structures.

**HB 2952** - Establishes new subaccount within State Forestry Department Account.

**HB 2953** - Requires State Forestry Department to report to committee of Legislative Assembly regarding environmental and employment impacts of Good Neighbor Authority Agreement projects funded in whole or in part by moneys made available to department for project purposes.

**HB 3012** - Directs Department of Human Services to conduct study that identifies ways to improve foster care system in this state and present report to interim committees of Legislative Assembly related to human services on or before September 15, 2019.

**HB 3013** - Provides tuition and fee remission for natural child of foster parent if natural child attends institution of higher education. Bases remission percentage on aggregate number of years foster parent provided foster home to one or more foster children.

**HB 3014** - Modifies crime of assault in the first degree to include intentionally or knowingly causing permanent physical injury to another person. Requires mandatory minimum sentence of 300 months' imprisonment upon conviction.

**HB 3015** - Permits former adopted foster children to have amount of tuition and all fees waived if attending defined institutions of higher education for purposes of pursuing initial undergraduate degree.

**HB 3046** - Requires Oregon Department of Administrative Services to include tribal boundaries on any legislative district maps department produces.

**HB 3047** - Modifies juvenile court dependency procedure to require any party issuing summons to bear financial responsibility for certain costs arising out of issuance of summons.

**SB 155** - Requires all investigations involving suspected abuse or sexual conduct by school employees to be conducted by Teacher Standards and Practices Commission.

**SB 448** - Directs Office of Outdoor Recreation to study and make recommendations on development of Oregon Outdoors Pass.
