Business and Labor Committee

Monday, April 1, 8:00am, HR E

Public Hearing and Possible Work Session

- [HB 2333](#) CARRIED OVER FROM 3-27-2019 AGENDA: Defines "park model recreational vehicle."
- [HB 3009](#) Requires public employer to provide exclusive bargaining representative reasonable access to new employees in appropriate bargaining unit within 90 days of employee becoming part of bargaining unit.
- [HB 2231](#) Provides right to collectively bargain with State of Oregon to interpreters who receive compensation paid by state for providing interpretation services.
- [HB 2992](#) Establishes as condition of enforceability of noncompetition agreement that employer provide signed, written copy of terms of agreement to employee within seven days after termination of employee's employment.
- [HB 3389](#) Provides that name and address of lottery prize winner are confidential and may not be publicly disclosed by Oregon State Lottery Commission or Oregon State Lottery unless prize winner provides written authorization for disclosure

Work Session

- [HB 2787](#) CARRIED OVER FROM 3-27-2019 AGENDA: Specifies that certain taxes related to transacting wet marine and transportation insurance in this state apply to authorized insurers.
- [HB 3131](#) CARRIED OVER FROM 3-27-2019 AGENDA: Permits insurer to exclude from coverage under motor vehicle liability insurance policy person other than named insured based on certain specified criteria.
- [HB 3193](#) CARRIED OVER FROM 3-27-2019 AGENDA: Requires that, for employers that are contractors licensed by Construction Contractors Board, order of determination must include statement that failure to pay amounts determined to be owed to wage claimant shall result in Commissioner of Bureau of Labor and Industries notifying board of such failure and board's suspension of contractor's license.
- [HB 2341](#) Makes unlawful employment practice for employer to deny reasonable accommodation to known limitations related to pregnancy, childbirth or related medical condition or to take certain actions related to reasonable accommodations to known limitations related to pregnancy, childbirth or related medical condition.
- [HB 2593](#) Conforms Oregon law related to expression of milk in workplace to federal law.
- [HB 2998](#) Removes requirement that documents related to business organizations that are submitted for filing to Secretary of State must be in English language.

- Note Change: HB 2252, HB 2212, HB 2400, and HB 2001 have been removed

- *NOTE CHANGE: HB 3252, HB 3312, HB 2490, and HB 3001 have been removed*

Wednesday April 3, 8:00am, HR E

Public Hearing and Possible Work Session

- [HB 2417](#) Establishes alternate death benefit for surviving spouse of member of Public Employees Retirement System who dies before retirement.
- [HB 2646](#) Provides that for purposes of determining salary of certain member of Public Employees Retirement System, housing allowance paid to prison chaplain shall be treated as includable in member's taxable income under Oregon law.
- [HB 2647](#) Allows certain police officers commissioned by Oregon Health and Science University to elect to discontinue participation in alternative retirement program and to elect to participate in Public Employees Retirement System for purposes of service performed as police officer commissioned by Oregon Health and Science University on and after date of election.
- [HB 2786](#) Provides that district attorneys and deputy district attorneys qualify as police officers under Public Employees Retirement System.
- [HB 2861](#) Directs Public Employees Retirement Board to provide members of individual account program of Public Employees Retirement System with written disclosure statement about investment options available under program.
- [HB 3130](#) Exempts retired member of Public Employees Retirement System from limitations on reemployment if member is reemployed for purposes of providing security to Governor's residence or judges or for purposes of law enforcement related to access and habitat programs.
- [HB 2838](#) Provides that hours worked by retired police officer employed by school district to provide law enforcement, security or safety services do not count for purposes of limitations on reemployment of retired member of Public Employees Retirement System.
- [HB 2972](#) Authorizes Harney County Health District to offer alternative retirement programs in addition to Public Employees Retirement System.
- [HB 3252](#) Excludes certain employees of Oregon State Police from meaning of supervisory employee for purposes of public employment.

Work Session

- [HB 3101](#) Extends from July 1, 2019, to July 1, 2023, period of time public universities must provide scope and value of specified employee benefits.

Monday April 8, 8:00am HR E

Public Hearing and Possible Work Session

- [HB 3120](#) Provides that individual may not be disqualified for unemployment insurance benefits for voluntarily leaving work, failing to apply for available suitable

insurance benefits for voluntarily leaving work, failing to apply for available suitable work or failing to accept suitable work, if individual or member of individual's immediate family was victim of crime of intimidation, individual believes that individual or immediate family member could become victim of crime of intimidation or individual seeks to protect individual or immediately family member from crime of intimidation that individual reasonably believes will occur as a result of individual's continued employment or acceptance of work.

- [HB 3152](#) Prohibits person, other than governmental entity or other person acting in accordance with federal, state or local law or under court order, from obtaining, sharing, selling, copying, transmitting, using, producing, generating or providing protected dealer data without motor vehicle dealer's prior express written consent or in any manner that is not consistent with dealer's prior express written consent.
- [HB 2408](#) Defines "funds of a public agency," for purposes of applying prevailing rate of wage to projects for public works, to include tax credits or tax abatements that contractor engaged in public works project receives from state in connection with project.
- [HB 3416](#) For purposes of unemployment insurance law, modifies exclusion from definition of "employment" for individuals making sales of consumer goods or services in home or otherwise than in permanent retail establishment.

Work Session

- [HB 2415](#) Prohibits retainage or performance security deduction from portion of progress payment relating to cost of materials or equipment stored at job site.
- [HB 3109](#) Directs Oregon Business Development Department to study tax incentives for cybersecurity businesses and to report its findings to interim legislative committees related to economic development on or before September 15, 2020.
- [HB 3030](#) Allows professional licensing board to issue temporary authorization to spouse of member of Armed Forces of United States stationed in Oregon and who holds out-of-state authorization to provide occupational or professional service.
- [HB 3031](#) Creates family and medical leave insurance program to provide employee who is eligible for coverage with portion of wages while employee is on family and medical leave or military family leave.
- [HB 3023](#) Requires transportation network company that operates in this state to obtain license from Department of Transportation.
- [HB 2886](#) Modifies law regarding requirement that public employer grant preference to veteran or disabled veteran in selection process for civil service position.
- [HB 2423](#) Adopts Small Home Specialty Code to regulate construction of homes not more than 400 square feet in size.
- [HB 2419](#) Permits Department of Consumer and Business Services to issue licenses and conduct criminal records checks through Nationwide Multistate Licensing System.
- [HB 3022](#) Makes various changes to workers' compensation laws of this state.

- [HB 2418](#) Specifies certain presumptions as to cause of death, disability or impairment of health of fire service professional, public safety personnel or employee of public or private safety agency with duties related to firefighting, police, ambulance or emergency medical services in claim for benefits related to occupational disease under workers' compensation law.
- [HB 2804](#) Prohibits retail pet store from selling or offering to sell dog, cat or rabbit acquired from source other than animal shelter or rescue organization.
- [HB 3001](#) Provides that peer-to-peer car rental program shall be subject to same airport fees and state and local law, including taxes and fees, as car rental company.

Public Hearing and Possible Work Session

- [HB 3081](#) Directs Oregon Department of Administrative Services to distribute moneys to Klamath County to acquire and install stream gauges in Klamath Basin.

Work Session

- [HB 2361](#) Requires State Fish and Wildlife Commission to establish and prescribe fees for multiyear resident and nonresident hunting licenses.
- [HB 2377](#) Appropriates moneys from General Fund to Oregon Department of Administrative Services for payment to Douglas Timber Operators for purpose of implementing first phase of sediment study of lower Rogue River.
- [HB 2747](#) Revises requirements for membership on State Fish and Wildlife Commission.
- [HB 2923](#) Classifies certain persons as resident persons for purpose of purchasing licenses, tags and permits issued by State Fish and Wildlife Commission.
- [HB 3227](#) Establishes Excessive Elk Damage Pilot Program.
- [HB 3168](#) Authorizes operation of boats propelled by electric motors on named lakes and waters of this state under certain circumstances.

Public Hearing and Possible Work Session

- [HB 3035](#) Increases maximum penalty for certain wildlife law offenses committed without culpable mental state to \$2,000 fine.
- [HB 3087](#) Directs State Department of Fish and Wildlife to establish anti-poaching awareness program.
- [HB 3088](#) Increases maximum penalty for certain wildlife law offenses committed with culpable mental state to five years' incarceration, \$125,000 fine, or both.

Public Hearing

- [HB 2179](#) Establishes Task Force on Blockchain Applications and Legislation.
- [HB 2948](#) Directs Trust for Cultural Development Board to study issues related to administration of Trust for Cultural Development Account and report to appropriate committee or interim committee of Legislative Assembly.
- [HB 3113](#) Increases number of premises at which winery licensee may import, process, store and export wine or cider and sell malt beverages, wine and cider.
- [HB 3239](#) Removes limit on number of full on-premises sales licenses that distillery licensee may hold.
- [HB 2384](#) CARRIED OVER FROM THE 3/27/19 AGENDA: Appropriates moneys from General Fund to Oregon Department of Administrative Services for distribution to Curry County for purpose of installing fiber optic telecommunication line to Cape Blanco Airport.
- [HB 2810](#) CARRIED OVER FROM THE 3/27/19 AGENDA: Appropriates moneys from General Fund to Oregon Department of Administrative Services for distribution to Historic Portland Public Market Foundation for predevelopment expenses for James Beard Public Market.

Work Session

- [HB 2053](#) CARRIED OVER FROM THE 3/27/19 AGENDA: Modifies provisions related to employment and employee compensation for Oregon Business Retention and Expansion Program, enterprise zones, long term incentives for rural enterprise zones and business development income tax exemption.
- [HB 2174](#) CARRIED OVER FROM THE 3/27/19 AGENDA: For urban renewal plan proposed on or after July 1, 2019, that includes public building project, requires concurrence of at least three of four taxing districts estimated to forgo most property tax revenue under proposed plan.
- [HB 2613](#) CARRIED OVER FROM THE 3/27/19 AGENDA: Requires Oregon Business Development Department to prepare and report master plan for county fairground capital construction.
- [HB 2672](#) CARRIED OVER FROM THE 3/27/19 AGENDA: Authorizes Department of Revenue to reimburse State Department of Agriculture, State Department of Energy and Water Resources Department for expenses incurred in administration and enforcement of activities related to cannabis.
- [HB 3110](#) CARRIED OVER FROM THE 3/27/19 AGENDA: Creates Oregon Rural Service Center within Oregon Business Development Department to assist rural counties, and cities and special districts located in rural areas, to apply for and

manage public and private funding opportunities for purposes of workforce and economic development.

- [HB 3211](#) CARRIED OVER FROM THE 3/27/19 AGENDA: Directs State Department of Agriculture to advance design of cannabis business certification program.

Wednesday April 3, 1:00pm HR D

Public Hearing and Possible Work Session

- [HB 2098](#) Establishes that recreational marijuana licensure renewal fees are nonrefundable if applicant is conditionally or unconditionally authorized to operate marijuana establishment.
- [HB 3386](#) Identifies types of businesses eligible to deliver distilled liquor, malt beverages, wine or cider to person taking possession for personal or social use.
- [HB 3395](#) Allows person responsible for marijuana grow site who is designated to grow marijuana by more than three registry identification cardholders to transfer usable marijuana to additional registry identification cardholders.

Work Session

- [HB 2054](#) Makes program changes to Oregon Innovation Council statutes.
- [HB 2181](#) Requires State Workforce and Talent Development Board to conduct study and analyze how to best implement recommendations developed by Task Force on Maritime Sector Workforce Development.
- [HB 2243](#) Defines "public library" as public facility providing free and equal access to library and information services for all residents of local government unit.
- [HB 2310](#) Establishes Prosperity 1,000 Pilot Program to provide career coaching, occupational training and job placement services for at least 1,000 low-income job seekers residing in areas of concentrated poverty.
- [HB 2320](#) Provides that fixed percentage of certain forecasted video lottery revenues, adjusted for certain allocations to Regional Solutions Program, be transferred to counties for economic development.
- [HB 2454](#) Allows out-of-state applicant seeking occupational license in Oregon more time to meet Oregon standards if applicant is already licensed in another state and is seeking to work in Eastern Oregon Border Economic Development Region.
- [HB 2900](#) Extends sunset of exemption from property taxation for qualified machinery and equipment that is used in food processing.
- [HB 2909](#) Allows delivery of marijuana items, pursuant to bona fide orders, to consumers within city or county in which marijuana retailer is located and to consumers in cities or counties that have adopted ordinances allowing for delivery of marijuana items from adjacent cities or counties.
- [HB 2933](#) Clarifies, for purposes of Eastern Oregon Border Economic Development Board activities, that "workforce development" includes development of residential

housing necessary to attract and keep employees in Eastern Oregon Border Economic Development Region.

- [HB 3061](#) Allows political subdivision to convey real property to nonprofit, municipal or private corporation for purpose of providing broadband service.
- [HB 3251](#) Authorizes Oregon Business Development Department to make loans

Work Session

- [HB 2179](#) Establishes Task Force on Blockchain Applications and Legislation.
- [HB 2366](#) Allocates \$1,600,000 of lottery revenue to Oregon Business Development Department to be used to issue grants or loans in support of redevelopment of Port of Port Orford Cannery.
- [HB 2383](#) Appropriates moneys for distribution to Curry County assessor for pilot program to increase employment in assessor's office in order to achieve assessment rotation of seven years for taxable property.
- [HB 3113](#) Increases number of premises at which winery licensee may import, process, store and export wine or cider and sell malt beverages, wine and cider.
- [HB 3169](#) Provides that banking institutions and credit unions may organize as limited charter cannabis financial institutions.
- [HB 3200](#) Requires applicant for marijuana production license that does not own premises at which marijuana will be produced to submit signed informed consent of owner of premises to Oregon Liquor Control Commission.
- [HB 3239](#) Removes limit on number of full on-premises sales licenses that distillery licensee may hold
