
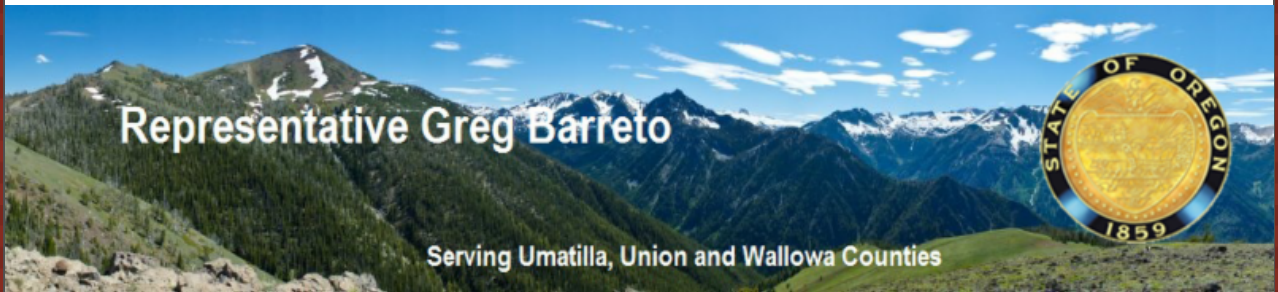

Business and Labor Committee

Monday April 22. 8:00am, HR E

Public Hearing

- [HB 2688](#) Requires original equipment manufacturer to make available to owner of digital electronic equipment or independent repair provider on fair and reasonable terms any part, tool, service manual or other device, implement or information that original equipment manufacturer makes available to authorized repair provider for purpose of diagnosing, maintaining or repairing digital electronic equipment that original equipment manufacturer makes or supplies.

Work Session

- [SB 39](#) Replaces exemption from laws regulating practice of engineering, land surveying and photogrammetric mapping with exemption from registration requirement
- [SB 43](#) A Authorizes State Board of Geologist Examiners to adopt rules prescribing continuing education requirements.
- [SB 71](#) Allows use of sedative and analgesic medications when euthanizing animals.
- [SB 109](#) A Specifies that certain documents prepared by or for internal use of financial institutions are not real estate appraisal activity requiring preparer of document to carry real estate appraiser certification, license or registration.
- [SB 422](#) Expands definition of "natural hair care" to include shampooing and conditioning.

Public Hearing

- [SB 227](#) Authorizes cemetery authority, or person with authority to determine disposition of human remains, to move, temporarily store or reinter human remains dislodged from original cemetery plot by natural disaster or other similar emergency
- [SB 294](#) Authorizes annexation of land to pioneer cemetery maintenance district upon petition by owner and approval of governing body of district.
- [SB 298](#) A Allows employee or agent of funeral home or person acting as funeral service practitioner named in record of death or fetal death to request certified copy of record of death or fetal death at any time following date of death.
- [SB 519](#) A Increases minimum wage exemption for purposes of garnishment and execution.
- [SB 272](#) Includes assistant attorneys general among public employees who are prohibited from striking.

Work Session

- [SB 164](#) A Makes employer's failure to comply with requirements of Oregon Retirement Savings Plan unlawful practice.
- [SB 251](#) A Updates various statutes in Insurance Code to reflect changes in National Association of Insurance Commissioners model provisions related to reducing reserve requirements for domestic ceding insurers that cede insurance to reinsurers and to regulating insurance adjusters and insurance consultants.
- [SB 366](#) Removes sunset from statutes that regulate guaranteed asset protection waivers.

- [SB 50](#) A Exempts from Public Contracting Code timber sales from lands that State Parks and Recreation Commission or State Parks and Recreation Department owns or manages.
- [SB 753](#) Authorizes executive director of Oregon Ocean Science Trust to enter into agreement with private, nonprofit organization under which organization shall solicit gifts, grants and donations in support of work of trust.
